

**The Camden (Prescribed Routes) (No.2) Traffic Order 2019**  
**The Camden (Waiting and Loading Restrictions) (Civil Enforcement Area) (Amendment No. 95) Traffic Order 2019**

Notice is hereby given that the Council of the London Borough of Camden proposes to make the above Orders under Sections 6, 124 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984, as amended. The general nature and effect of the orders are:

**Saffron Street, EC1N:**

No vehicles, other than cycles, will be permitted to enter the section of Saffron Street that lies between its junctions with Saffron Hill and Onslow Street. Cyclists may travel in both directions along the entire street.

24-hour waiting and loading restrictions to apply from the junction with Saffron Hill eastwards to the projected eastern kerblines of Onslow Gardens.

**Onslow Street, EC1N:**

The prohibition on waiting by vehicles will be extended to apply at all times throughout the whole length of the street. A prohibition on loading will be introduced on both sides of the road from the junction with Saffron Street northwards for approximately 18 metres. Cyclists will be permitted to turn right into Saffron Street.

**STATEMENT OF REASONS**

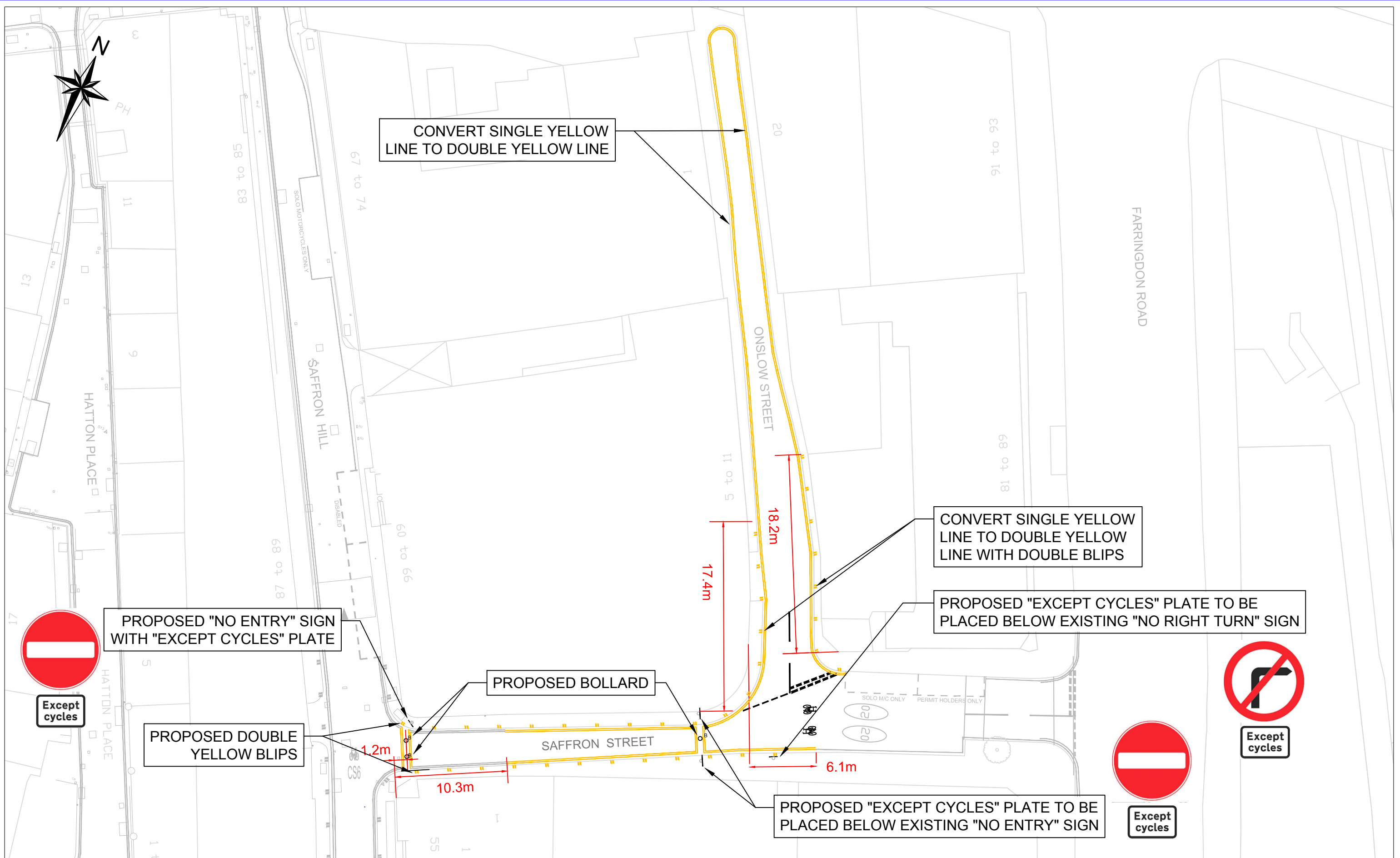
**Saffron Street, EC1N:**

The proposed measures would improve cycling access in Saffron Street in line with Camden's Transport Strategy which seeks to encourage sustainable transport and healthier forms of travel, in particular walking and cycling.

**Onslow Street, EC1N:**

The proposed changes to waiting and loading restrictions are intended to address issues of vehicles blocking private garage access in Onslow Street.

#### **2. Interpretation**

- 2.1 In this order;
- 2.1.1 the term "parent order" means the Camden (Waiting and Loading Restrictions) (Civil Enforcement Area) Traffic Order 2012 [L.B.C 2012 No. 1];
- 2.1.2 any reference in this order to any enactment shall be construed as a reference to that enactment as amended, applied, consolidated, re-enacted by or as having effect by virtue of any subsequent enactment;
- 2.1.3 unless the context otherwise requires, any expression used in this order which is also used in the parent order shall have the same meaning as in that order.

#### **3. Amendments to schedules 1 and 2 to the parent order**

- 3.1 Without prejudice to the validity of anything done or to any liability incurred in respect of any act or omission before the coming into force of this order the parent order shall have effect as though;
- 3.1.1 there was substituted for the items set out in relation to the similarly named streets in schedule 1 to the parent order, the items set out in table 1 of the schedule to this order;
- 3.1.2 there was included in schedule 2 to the parent order, the items set out in relation to the streets named in table 2 of the schedule to this order.

#### **1. Citation and commencement**

- 1.1 This order shall come into force on \_\_\_\_\_ and may be cited as the Camden (Prescribed Routes) (No. 2) Traffic Order 2019.

#### **2. Interpretation**

- 2.1 Any reference in this order to any enactment shall be construed as a reference to that enactment as amended, applied, consolidated, re-enacted by or as having effect by virtue of any subsequent enactment.

#### **3. Restriction**

- 3.1 No person shall cause any vehicle, other than a cycle, to enter that section of Saffron Street which lies between its junction with Saffron Hill and the western kerb line of Onslow Street.

#### **4. Exemptions**

- 4.1 Nothing in Article 3 shall apply in respect of;
- 4.1.1 anything done with the permission of a police constable or traffic warden in uniform;
- 4.1.2 a vehicle being used by the police, ambulance service or fire brigade in an emergency;
- 4.1.2 any person causing any vehicle to proceed in accordance with any restriction or requirement indicated by traffic signs placed pursuant to Section 66 or 67 of the Road Traffic Regulation Act 1984.
