The Camden (Loading Places) (Amendment No. 29) Traffic Order 2020

Notice is hereby given that the Council of the London Borough of Camden proposes to make the above orders under Sections 6 and 124 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984, as amended. The general nature and effect of the orders will be to designate and/or amend waiting and loading restrictions and parking places as set out below.

Waiting and loading prohibitions will apply at all times at the locations below:

along the length of the lengths of Shaftesbury Avenue which lie north of High Holborn (with the exception of the loading bay to be designated opposite no. 232;

along the length of Shaftesbury Avenue from the junction with St. Giles High Street / High Holborn south-westwards to the junction with Neal Street / Mercer Street (with the exception of the loading bay on the south-east side mid-way between the junctions);

in High Holborn from the junction with St. Giles High street to a point 10 metres east of the junction with Museum Street (with the exception of the loading bay to be designated outside the Shaftesbury Theatre and the parking places located on the south side);

in New Oxford Street between the junctions with Bloomsbury Street and Bloomsbury Way

in Grape Street from the junction with High Holborn to a point 7 metres north of that junction and from the junction with Shaftesbury Avenue for a distance of 5 metres south-west of that junction;

in Coptic Street from the junction with New Oxford Street to a point 15 metres north of that junction;

in West Central Street from the junction with Shaftesbury Avenue for a distance of 15 metres eastwards;

in Drury Lane from the junction with High Holborn southwards for a distance of 15 metres;

in Endell Street from the junction with High Holborn southwards for a distance of 15 metres on the west side and 5 metres on the east side.

Loading bays will be designated in Shaftesbury Avenue, opposite nos. 230 – 234 and in High Holborn, outside the Shaftesbury Theatre. A loading bay on the south side of Store Street, between the junctions with South Crescent will be revoked and a cycle docking station installed in its place.

The motorcycle parking place located outside no. 83 Endell Street will be revoked.




The measures form a part of Camden's West End Project.






